Tournament Rules

1. **Eligibility:** All participants must be USBC members.
2. **Entering Average:** Entrants will use highest book (winter) average of at least 21 games from the 2017-18 seasons. If none, use January 1, 2019 average of 21 games or more. If none, then a current average of 21 games will be used with league standing sheet provided. If a bowler has a January 1, 2019 average that is ten pins or more higher than their submitted average, then that average will be used.
3. **Bowlers are responsible** for verifying their own average at registration. If the submitted average is lower than the average verified by the tournament committee, then the entire doubles team score may be disqualified. If a bowler has a January 1, 2019 average that is ten pins or more higher than their submitted average, then that average will be used.
4. **Handicap:** Shall be 90% of the difference of combined entering average and 480. Both averages will be added together, subtracted from 480, and then the handicap will be 90% of that number for each game.
5. **Format:** Teams will bowl three (3) games on one pair of lanes.
6. **Multiple Entries:** Entrants may bowl more than once, but must bowl with a different partner each time.
7. **Awards:** Ratio of at least 1:5. All awards fees returned 100%. Fees per bowler: Lineage \$10.50, Prize Fund \$10, Expenses \$2.
8. **Protests/Appeals:** Protests and appeals must be made in writing stating grounds for the protest or appeal within 72 hours of the infraction. (Rule 329a).
9. **USBC Rules:** USBC rules will govern any rules not covered by the above.
10. **Entries:** Pre-registration will close on July 8, 2019, to help ensure that entrants get their first choice for date and squad times. Walk-in entries may be allowed depending on lane availability.
11. A **\$25.00 service fee** will be charged for all returned checks.
