## Tournament Rules

**Eligibility:** All participants must be an active 2019-20 USBC member in good standing and age 50 and above prior to tournament date.

**Format:** Bowlers will bowl five games skipping a pair after each game. A 1:5 ratio of bowlers will make it into match play. Top 16 will make it based on 80 entries. All qualifiers for match play **CASH**. Match play will be two game single elimination with matches being four bracket style finals, four bowlers per bracket. First round will be as follows, Bracket A, #1 vs. #16, #5 vs. #12. Bracket B, #2 vs. #15, #6 vs. #11. Bracket C, #3 vs. #14, #7 vs. #10. Bracket D, #4 vs. #13, #8 vs. #9. Winner of bracket A will face winner of Bracket D, winner of Bracket B will face winner of Bracket C. The highest scoring Super Senior (age 65 and above) that doesn't qualify for match play will receive a cash award. **LANE CONDITION MODIFIED HOUSE SHOT.**

**Entry Fee:** \$80.00 breaks down as follows: Lineage: \$19.00, Expense: \$5.00 Prize Fund: \$56.00. Day of tournament entry fee will be \$100.00 cash only. All entries paid by check must be submitted by Tuesday April 14<sup>th</sup> to the GSA office. Make checks payable to GSA USBC, **all return checks will be charged a \$35 service fee.**

**Awards:** Bowlers advancing to match play will cash. Additional awards will be dependent on the number of entries.

**Conduct:** Good sportsmanship is required by all participants. Any unsportsmanlike behavior will be addressed by the tournament committee and may result in a warning or disqualification.

**General Provisions:** Only participants and tournament personnel are allowed in the settee area. No food or drink is allowed in settee area. No powdery product, i.e. Easy Slide, baby powder, may be applied to bowling shoes or equipment at any time. Also no audio devices are allowed in the bowler's area to include cell phones. Cell phones must be in silent mode.

**Protests/Appeals:** Any protest or appeals must be presented to the tournament chair prior to start of the next game. USBC rules will govern any aspect of tournament play that is not specifically addressed in these rules.
